Findings of Facts & Conclusions of Law

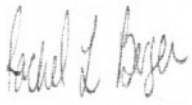
Petitioner, NYC Department of Environmental Protection (DEP) did not appear. Respondent, HUGH OKANE ELECTRIC CO INC, appeared and was represented by Lance Chebin.

The summons alleges a violation of Administrative Code section 24-163 for IDLING OF MOTOR VEHICLE ENGINE MORE THAN THREE MINUTES 3RD AND SUBSEQUENT

Mr. Chebin said Respondent denies the allegations with no evidence in rebuttal.

I find Petitioner established a prima facie case. I credit the summons and find it establishes a third or subsequent offense violation. I find Respondent did not establish a defense.

Accordingly, the summons is sustained.
