**Findings of Fact & Conclusions of Law**

The NYC Department of Environmental Protection waived their appearance (marked Hearing Officer's Exhibit) at a telephone hearing on June 11, 2026. Registered representative ILMA BABU appeared on behalf of Respondent ANT'S TOWING CORP. Respondent's representative waived the use of a translator, a formal reading of the charges, the assistance of counsel and the presence of the issuing officer.

The summons alleges a violation of NYC Administrative Code 24-163: idling motor vehicle engine for more than 3 minutes. Date of occurrence was 05/21/24. This is a third offense.

Respondent denied the allegations and offered no rebuttal. No additional evidence was submitted.

I credit the sworn statement of the issuing officer and find that Petitioner established the violation. Respondent failed to rebut the allegations and present a valid legal defense.

Therefore, the summons is sustained and enhance penalty as a third offense is imposed.
