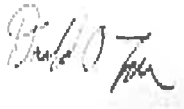
Summons #000956832R, #000956949K and 000956971R charged violations of 24-163 of the Administrative Code, idling a motor vehicle engine for longer than three minutes.

Summons #000956821L charged a violation of 24-163(f) of the Administrative Code, idling a motor vehicle engine, idling a motor vehicle engine for more than one minute while adjacent to a school or park, charged as a second violation.

Summons #000956827M charged a violation of 24-163 of the Administrative Code, idling a motor vehicle engine for longer than three minutes, charged as a third or subsequent violation.

Respondent denied, but did not rebut, the allegations in the summonses.

I credit the summonses. The summonses are sustained.
