Findings of Facts & Conclusions of Law

The respondent Penske Truck Leasing Corporation was issued four summonses.

Summons # 00090714P was issued for a violation of section 24-163; idling of a motor vehicle engine for more than three minutes, or when at a terminal point, for any period of time, 1st offense.

Summons # 000990998X was issued for a violation of section 24-163(f); idling of a motor vehicle engine for more than one minutes while adjacent to school or park, 1st offense.

Summons # 000991367Y was issued for a violation of section 24-163; idling of a motor vehicle engine for more than three minutes, or when at a terminal point, for any period of time, 3rd offense.

Summons # 000991540Z was issued for a violation of section 24-163; idling of a motor vehicle engine for more than three minutes, or when at a terminal point for any period of time, 1st offense.

Alexander Stratis appeared for the respondent.

Edward Sferrazza appeared for the Petitioner, DEP.

The summonses are credited.

The respondent denied the charges and did not offer a rebuttal.

The respondent did not contest that summons # 67Y was a third offense.

Since the respondent denied the charges and did not offer a rebuttal, the summonses are sustained and the following penalties are imposed: for summonses 14P, 98X, and 40Z, a first offense penalty in the amount of \$350.00 and for summons # 67Y, a third offense penalty in the amount of \$600.00.
