**Findings of Fact & Conclusions of Law**

Petitioner did not appear. Respondent appeared through attorney Michael Nacmias.

Summons 0221323017 charged a violation of Administrative Code § 19-190(b) for failing to yield at a crosswalk resulting in physical injury to a pedestrian or cyclist.

The issuing officer wrote, "At TPO, officer was informed by Deft. He was struck by a vehicle that failed to yield upon a left turn."

No penalty is written in either the mail-in or maximum penalty blank.

Respondent moved to dismiss the charge for failure to state a case. Respondent argued that it does not allege a physical injury, and that the wording does not allege there was a pedestrian involved.

Section 19-190(b) imposes a fine on a motor vehicle that fails to yield to a pedestrian, comes in contact with the pedestrian, and causes a physical injury.

Respondent's motion to dismiss is granted.
