**Findings of Fact & Conclusions of Law**

MABEL OGHOJA FOR for Respondent, CERTIFIED LUMBER LLC appeared for a hearing by telephone on February 5, 2025. Petitioner, Department of Environmental Protection appeared by John McLaughlin.

Respondent is charged with a violation of the New York City Administrative Code Section 24-163 for causing or permitting to cause the idling of a motor vehicle for longer than 3 minutes.

At the hearing, Respondent's Attorney states that he has reviewed Petitioner's evidence and denies the charges with no rebuttal.

I credit Petitioner's evidence and find it sufficient to establish the charge. Respondent does not present a valid defense to the charge. Therefore, the violation is sustained, and the standard penalty is imposed.
