Findings of Facts & Conclusions of Law

Respondent Silvercup Scaffolding appeared by Michael Sargo; petitioner Department of Sanitation was not present. The hearing considered five summonses, as to each of which respondent denied but did not rebut the charge. I credit petitioner's evidence, find it supports a violation of the cited section of law in each summons, and sustain each summons. A description of each charge and the assessed penalty is set forth below.

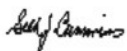
Summons # 47521571K: NYC AC 24-149, open fire burning contaminants. Penalty is \$350.00

Summons # 47521572M: NYC AC 16-122(b), obstruction of traffic with supplies stored in street. Penalty is \$100.00.

Summons # 47521573Y: NYC AC 16-118(2)(a), obstruction of pedestrian pathway with vehicles and large accumulation of pieces of wood and metal. Penalty is \$50.00.

Summons # 47521581Y: NYC AC 19-121(a), construction material for scaffolding stored in street without a permit. Penalty is \$750.00.

Summons # 47521583H: NYC AC 16-122(b), storage of scaffolding materials in street near curb obstructing traffic. Penalty is \$100.00.
