Findings of Fact & Conclusions of Law

Petitioner did not appear. Respondent appeared through Frank Tamberino.

Summons 0977124F0 charged a Condition 3 violation of NYCHC 81.09(a); a Condition 1 violation of NYCHC 81.07(a)(2); a Condition 5 violation of NYCHC 81.23(a); three violations of NYCHC 81.23(a); a Condition 2 violation of NYCHC 81.20(b); and a Condition 1 violation of NYCHC 81.17(e)(3).

For each line item, Respondent denied the charge, but offered no rebuttal.

I credit the issuing officer. As Respondent has not offered testimony or evidence, the summons is sustained.
