**Findings of Fact & Conclusions of Law**

Authorized representative Lance Chebin appeared at the hearing by phone for Respondent. Michael Grosso appeared by phone for Petitioner. Respondent was charged with a second offense violation of 24-163 for idling of a motor vehicle engine for more than three minutes. Mr. Chebin requested an adjournment. As this case was previously adjourned several times and no reason was given for the need for further adjournment, the request was denied. Mr. Chebin did not dispute that this was a second offense. He denied the violation, offering no rebuttal.

I credit the summons as written. I do not credit Respondent's general denial.

Accordingly, I find Respondent in violation and impose the minimum second offense penalty of \$440.00.
