**Findings of Fact & Conclusions of Law**

The hearing on summons number 000953616Z was conducted by telephone conference call on March 10, 2026.

Respondent CITYWIDE CONTAINER SERVICE CORP appeared at the hearing through authorized representative Ilma Babu. Petitioner Department of Environmental Protection, by Michael Grosso, waived its appearance via email due to a lack of available representatives.

The Issuing Officer alleges in the summons that Respondent violated New York City Administrative Code 24-163 for idling of a motor vehicle engine for more than three minutes. It is indicated as a first offense.

Respondent denies the charge with no rebuttal.

I credit the statements contained in the summons and find a violation of 24-163 as alleged. As Respondent does not refute the charge and does not put forth a defense, the summons is sustained, and the standard penalty imposed.
