**Findings of Fact & Conclusions of Law**

Registered Representative appeared on behalf of Respondent, USA SHRED LLC, at a hearing on October 20, 2025. Petitioner, Department of Environmental Protection, did not appear.

Respondent is charged with NYC Administrative Code Section 24-163.

Summons alleges that observed Respondent caused or permitted the idling of a motor vehicle while parked, standing, or stopped... 3rd and subsequent offense.

Respondent denied the charge but offered no rebuttal.

NYC Administrative Code Section 24-163 provides, in relevant parts, that no person shall cause or permit the engine of a motor vehicle to idle for longer than three minutes....

I credit the details of the summons. I find that the Respondent did not have a valid defense to the charge nor did they dispute the repeat charge. I find that the Respondent's vehicle was idle for longer than three minutes.

Accordingly, the Summons is sustained and the standard penalty of \$600 is imposed as a 3rd and subsequent offense.
