DECISION BASED ON FAILURE TO ANSWER SUMMONS

On 11/12/2024 at 4129 18 AVENUE BROOKLYN NY 11218, an agent from the DEPT. OF BUILDINGS gave summons 039130005H to 4127-29 18TH AVENUE LLC HEZI SALMAN. The agent claims that 4127-29 18TH AVENUE LLC HEZI SALMAN violated section AC 28-301.1 of the Administrative Code, the Rules of the City of New York, the New York City Health Code, or another City or State Law. The summons or a further notice instructed 4127-29 18TH AVENUE LLC HEZI SALMAN to come to OATH Hearings Division on 08/04/2025 for a hearing.

4127-29 18TH AVENUE LLC HEZI SALMAN did not come to OATH Hearings Division on 08/04/2025. The case has now been decided against 4127-29 18TH AVENUE LLC HEZI SALMAN. 4127-29 18TH AVENUE LLC HEZI SALMAN must pay a fine of \$6,250.00 and fix the problems shown on the summons immediately. To avoid paying \$6,250.00, 4127-29 18TH AVENUE LLC HEZI SALMAN must either:

- (A) Admit the violation, pay a special reduced fine of \$1,280.00 and fix the problems shown on the summons. Full payment must be received by OATH Hearings Division no more than 30 days from 08/11/2025. See the back of this paper for more instructions; or
- (B) Immediately ask for a new hearing. This is done by filling out the form called "Request for a New Hearing After a Failure to Appear." You can find this form on our website at: www.nyc.gov/oath. Or you can pick up the form at any OATH Hearings Division office.

A first request for a new hearing will be granted if it is received by OATH Hearings Division:

- no more than 75 days of the mailing or hand delivery date of the default decision.

If 4127-29 18TH AVENUE LLC HEZI SALMAN does not do either (A) or (B), 4127-29 18TH AVENUE LLC HEZI SALMAN must pay \$6,250.00. If 4127-29 18TH AVENUE LLC HEZI SALMAN does not pay \$6,250.00, the City will get a legal judgment against 4127-29 18TH AVENUE LLC HEZI SALMAN. Then the City can take money and property from 4127-29 18TH AVENUE LLC HEZI SALMAN to pay the fine.

The summons you received from the Department of Buildings contained an order from the Commissioner of the Department of Buildings directing you to timely correct the cited conditions and file a certificate of correction. Failure to do so may result in the Department of Buildings issuing you additional summonses charging violations of Administrative Code Section 28-201.1, for failure to comply with the order, and/or Administrative Code Section 28-204.4, for failure to file a certificate of correction.
