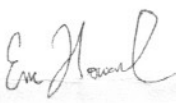

The hearing was held December 11, 2024. CHIA HAN LIN appeared on behalf of Respondent. Insp. Grosso appeared on behalf of DEP. The summons charges a violation of 24 -163 idling of a motor vehicle longer than 3 minutes.

Petitioner rests on the face of the summons. Respondent denies with no rebuttal.

I do not credit Respondent's general denial. Therefore, summons ending 73H, 93Y, and 92M are sustained. Standard penalty imposed.
