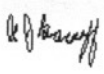
Findings of Facts & Conclusions of Law

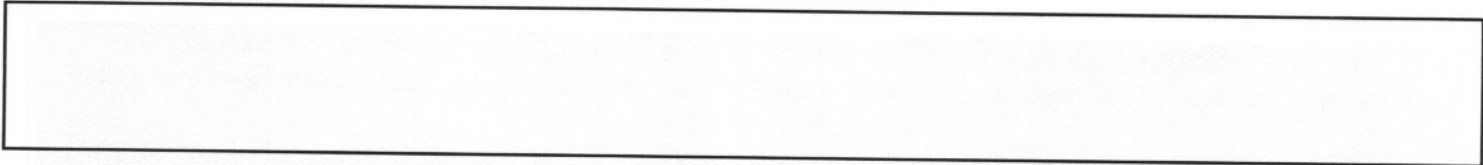
Chia-Han (Alfred) Lin appeared as the authorized representative of the named respondent. No appearance by the Department.

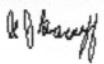
