**Findings of Fact & Conclusions of Law**

Respondent appeared at a remote telephonic hearing on 9/26/2025 by its authorized representative Ms. Nora Brown of the Nacmias Law Firm.

There was no appearance by Petitioner NYC Dept. of Environmental Protection.

Respondent is charged with a third violation of NYC Adm. Code 24-163 for allegedly causing or permitting the engine of the vehicle cited in the Summons to idle for more than 3 minutes while parked, standing, or stopped.

Ms. Brown stated that she reviewed the video taken by Petitioner. She did not dispute that this was a third violation of the cited section of law.

She denied the violation but presented no facts to rebut the allegations in the Summons and presented no valid legal defense to the charge.

I credit the unrefuted allegations in the Summons and find Respondent in violation.

Accordingly, the Summons is sustained, and the approved penalty for a third violation of the cited section of law is imposed.
