**Findings of Fact & Conclusions of Law**

Respondent CS TRUCKING LLC appeared at a remote telephonic hearing on 8/7/2025 by its authorized representative Mr. Joshua Santis of the Nacmias Law Firm.

There was no appearance by Petitioner NYC Dept. of Environmental Protection.

Respondent is charged with a first violation of NYC Adm. Code 24-163 for allegedly causing or permitting the engine of the vehicle cited in the Summons to idle for more than 3 minutes while parked, standing, or stopped.

Mr. Santis denied the violation but presented no facts to rebut the allegations in the Summons and presented no valid legal defense to the charge.

I credit the unrefuted allegations in the Summons and find Respondent in violation.

Accordingly, the Summons is sustained, and the approved penalty for a first violation of NYC Adm. Code 24-163 is imposed.
