**Findings of Fact & Conclusions of Law**

The hearing was held on August 4, 2025. Lance Chebin appeared on behalf of the Respondent. Senior Insp Dantney Parks appeared on behalf of Petitioner DEP. The summons charges a violation of RCNY 24-163 idling of motor vehicle engine for more than three minutes as second occurrence.

Petitioner rests on the face of the summons. Respondent denies the violation with no rebuttal. I do not credit Respondent's denial with no rebuttal. The summons provides a prima facie case.

Therefore summons sustained.
