**Findings of Fact & Conclusions of Law**

The hearing was conducted via telephone conference call on July 2, 2025.

Michael Nacmias, attorney for Respondent, appeared at the hearing. No appearance on behalf of petitioner NYPD.

The summons charges AC 19-190(B) for failure to yield causing serious injury. Respondent's representative motioned to dismiss for defective service as the affidavit of service was not signed and submitted an appeal. See Respondent's Exhibit. Respondent's representative also motioned to dismiss for failure to establish a prima facie case as the summons does not allege a vehicle, who had the right of way, and any serious injuries.

I find appeal no. 1801238, submitted by Respondent, on point here and controlling. Therefore, this summons is dismissed for defective service.
