Findings of Facts & Conclusions of Law

This remote hearing was conducted on June 18, 2025. Respondent (Penske Truck Leasing Corp) appeared by authorized representative, Lance Chebin. Senior Inspector Antwan Gibbs appeared for Petitioner (DEP).

For summons #000874414P, Respondent was charged with a violation of 24-163. Respondent caused or permitted the idling of a motor vehicle while parked, standing or stopped. As per DEP records, citizen observed TRUCK with NY License Plate #75872MN idling for longer than three minutes from 2/27/2024 11:12:16 AM to 2/27/2024 11:15:54 AM at 680 5th Ave.

For summons #000861460N, Respondent was charged with a violation of 24-163. Respondent caused or permitted the idling of a motor vehicle while parked, standing or stopped. As per DEP records, citizen observed TRUCK with NY License Plate #10686MM idling for longer than three minutes from 2/26/2024 11:18:07 AM to 2/26/2024 11:21:58 AM at 2 7th Ave.

For summons #000909841R, Respondent was charged with a violation of 24-163. Respondent caused or permitted the idling of a motor vehicle while parked, standing or stopped. As per DEP records, citizen observed TRUCK with IN License Plate # 3620476 idling for longer than three minutes from 11/12/2024 9:27:50 AM to 11/12/2024 9:33:00 AM at 1832 86th St.

For summons #000909872J, Respondent was charged with a violation of 24-163. Respondent caused or permitted the idling of a motor vehicle while parked, standing or stopped. As per DEP records, citizen observed TRUCK with NY License Plate # 81707ML idling for longer than three minutes from 7/30/2024 10:19:24 to 7/30/2024 10:23:48 AM at 363 W 17th St.

For summons #000909877Z, Respondent was charged with a violation of 24-163. Respondent caused or permitted the idling of a motor vehicle while parked, standing or stopped. As per DEP records, citizen observed TRUCK with NY License Plate # 1534ONE idling for longer than three minutes from 11/21/2024 11:59:00 AM to 11/21/2024 12:02:45 PM at 675 6th Ave.

For summons #000909979J, Respondent was charged with a violation of 24-163. Respondent caused or permitted the idling of a motor vehicle while parked, standing or stopped. As per DEP records, citizen observed TRUCK with IN License Plate # 3337732 idling for longer than three minutes from 6/22/2024 1:43:52 PM to 6/22/2024 1:47:22 PM at 419 E 9th St.

For summons #000910039H, Respondent was charged with a violation of 24-163. Respondent caused or permitted the idling of a motor vehicle while parked, standing or stopped. As per DEP records, citizen observed TRUCK with VA License Plate # 33585UA idling for longer than three minutes from 6/27/2024 5:00:54 PM to 6/27/2024 5:04:27 PM at 2 W 47th St.

For summons #000909939P, Respondent was charged with a violation of 24-163. Respondent caused or permitted the idling of a motor vehicle while parked, standing or stopped. As per DEP records, citizen observed TRUCK with NJ License Plate # XKAZ56 idling for longer than three minutes from 6/12/2024 11:54:24 AM to 6/12/2024 11:57:54 AM at 54 Claremont Ave.

Inspector Gibbs rested on the summonses.

Mr. Chebin stated, "DNR" for each of these eight (8) summonses.

Based on the record before me, I sustain these eight (8) summonses. I credit the issuing officers' affirmations of factual allegations. Respondent's representative denied the violations. However, he failed to present any credible rebuttal evidence, nor did present any legally valid defenses.

Accordingly, I sustain these summonses.

**IF YOU ARE FOUND IN VIOLATION, AND ARE NOT ELIGIBLE OR DO NOT CHOOSE
COMMUNITY SERVICE, YOU MUST PAY THE PENALTY WITHIN 30 DAYS OF THE DECISION

- To pay in person, bring a check, money order or credit card and this decision to any OATH Hearings Division location between 8:30 a.m. to 4:30 p.m.
- To pay online using a credit or debit card, go to www.nyc.gov/citypay/oath

If you do not pay the penalty, the City may: (1) file papers with the Civil Court ("docket a judgment"), (2) charge you a late fee, and (3) continue attempts to collect the debt.

**CAN I DO
COMMUNITY
SERVICE?**

If your summons is for the type of offense that gives you a Community Service option you can choose to complete Community Service instead of paying a penalty. Your decision will give you that option. You have to complete your Community Service by the deadline in the decision or else you will end up owing the penalty. You can even do your Community Service on the day you receive your decision.

**COMPLETION OF
COMMUNITY
SERVICE**

The Help Center will arrange for you to complete your Community Service. The Help Center is run by the Ombudsperson/*Pro Se* Clerk at OATH and is located at each Hearing Division in all five boroughs. To schedule your Community Service, call, email or visit a Help Center location.

If you do not complete your Community Service by the deadline, you will have to pay the penalty.

If you either completed the Community Service or paid the penalty, OATH will remove your identifying information from public records related to your case.

If you do not complete the Community Service or pay the penalty, your identifying information may remain on public records related to your case.

**IF YOU DISAGREE
WITH THE DECISION,
YOU MAY APPEAL IT**

To submit your appeal, you **MUST** use OATH's online or mail-in appeal forms available on OATH's website at www.nyc.gov/oath/appeal. Instructions for filing an appeal may be found on the form and OATH's website.

Your appeal **MUST** be received by the OATH Hearings Division **within 30 days** of the decision date, or 35 days if the decision was mailed to you.

To appeal you may need to pay the full penalty stated in this decision.

- If you cannot pay because of financial hardship, you may ask to not pre-pay by submitting with your appeal a Financial Hardship Application, available on OATH's website.
- If you are eligible and choose to perform Community Service instead of paying the penalty, you do not have to pay the penalty or complete the Community Service to appeal.

**APPEAL BY
ENFORCEMENT
AGENCY**

If you wish to answer an appeal filed by an enforcement agency, you **MUST** use OATH's Response To Appeal form. Instructions for filing an answer may be found on the form and OATH's website.

Your answer must be received **within 30 days** of the date of the enforcement agency's appeal, or 35 days if it was mailed to you.

If the enforcement agency wins the appeal, you may have to pay a penalty or, if eligible, complete Community Service even if your case was originally dismissed after the hearing.
