**Findings of Fact & Conclusions of Law**

A telephonic hearing was held on October 8, 2025.

Respondent was charged with a violation of Administrative code 24-163 in that Respondent caused or permitted the idling of a motor vehicle with NY license plate # 12943ML while parked, standing or stopped for longer than three minutes on 01/13/2025 on Bridge St between Willoughby St and Fulton St. This violation was listed as a third offense based on summonses 000787602R and 000787603Z.

Petitioner was represented Andy Guzman who relied on the summons.

Respondent was represented by Nora Brown who denied the violation without presenting any rebuttal.

Here, I credit the summons and find that the same are sufficient to establish the charged violation. I find that credible contrary evidence or a valid legal defense was not presented. Accordingly, the summons is SUSTAINED.
