Findings of Fact & Conclusions of Law

Nora Brown, authorized representative for the respondent, appeared via telephone conference call on 11/3/25. Joanne Guerra appeared on behalf of petitioner FDNY.

Respondent was charged with violating VC 19, affidavits, design and installation documents and other documentation.

Petitioner advised that they are relying on the summons and that they can see that correction was previously uploaded. Petitioner advised that respondent has established timely correction and recommended the mitigated penalty.

I credit the summons details and find that petitioner has established a valid charge against the respondent. Respondent has failed to establish a valid defense but has established timely correction. As such, and in accordance with petitioner's recommendation, I find respondent in violation and impose the mitigated penalty of \$300.
