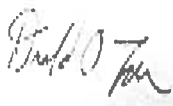

Findings of Facts & Conclusions of Law

The hearing was conducted by telephone on Court Call on January 13, 2026. Petitioner did not appear. Respondent was represented by authorized representative Ilma Babu.

Summons #00920704H charged a violation of 24-163(f) of the Administrative Code, idling a motor vehicle engine for longer than one minute while adjacent to a school. The remaining summonses charged violations of 24-163 of the Administrative Code, idling a motor vehicle engine for longer than three minutes.

Respondent denied, but did not rebut, the allegations in the summonses. I credit the summonses. The summonses are sustained.
