**Findings of Fact & Conclusions of Law**

The hearing on summons number 000935253J was conducted via telephone conference call on December 23, 2025.

Respondent PENSKE LEASING & RENTAL CO appeared at the hearing through attorney Ilma Babu. Petitioner Department of Environmental Protection, by Michael Grosso, waived its appearance via email due to a lack of available representatives.

The Issuing Officer alleges in the summons that Respondent violated New York City Administrative Code 24-163(f) for idling a motor vehicle engine inside a park for more than one minute. It is indicated as a first offense.

Respondent generally denies the matter but does not refute the charge and does not put forth a defense.

I credit the statements contained in the summons and find a violation of 24-163(f) as alleged. As Respondent does not refute the charge and does not put forth a defense, the summons is sustained, and the standard penalty imposed.
