Findings of Facts & Conclusions of Law

The respondent Penske Truck Leasing was issued six summonses.

Ilma Babu appeared for the respondent.

Senior Inspector Monica Dorson appeared for the Petitioner, DEP.

Summons # 000886227H, 00086417Z, 00086431P, 000938107P, and 0000938180L were issued for a violation of section 24-163; idling of a motor vehicle engine for more than three minutes as a first offense. Summons # 000937844K was issued for a violation of section 24-163, as a third offense.

The respondent denied the charges and did not offer a rebuttal.

The respondent did not contest that summons # 44K was a third offense.

The summonses are credited.

Since the respondent did not rebut the charges or provide a legally valid or meritorious defense, the summonses are sustained and a first offense penalty in the amount of \$350.00 is imposed for summonses # 27H, 17Z, 31P, 07P, and 80L. A third offense penalty in the amount of \$600.00 is imposed for 44K.
