Findings of Facts & Conclusions of Law

The respondent DHL Express Inc. was issued 10 summonses.

Ilma Babu appeared for the respondent.

Senior Inspector Leah Smith appeared for the Petitioner, DEP.

Summonses # 000978232K, 000978367H, 000978479M, 000978481L, 000978549Z, 000978552J were all issued for a violation of section 24-163; idling of a motor vehicle engine for more than three minutes, all a 3rd offense.

Summonses # 000978364M, 000978365Y, 000978480J, and 000978553L were issued for a violation of section 24-163(f); idling of a motor vehicle engine by a school or park for more than one minute, all a 3rd offense.

After viewing the videos, the respondent denied the charges and did not offer a rebuttal.

The respondent did not contest the prior summonses.

The summonses are credited.

Since the respondent denied the charges and did not offer a rebuttal, the summonses are sustained and a third offense penalty in the amount of \$600.00 are imposed for all the summonses.
