Findings of Facts & Conclusions of Law

Nora Brown appeared on behalf the Respondent as an authorized representative waiving translation, counsel and the appearance of the IO. The FDNY appeared via Khadija Hassan.

The summons ending in 81J, the Respondent is requesting mitigation. The recommends a standard penalty on all of the subviolations. But recommends the mitigated penalty on No. 3 only. I concur and impose standard penalties on No. 1 and 2 repectively, \$700 and \$750, and \$375 on No. 3 (VC27) as a mitigated penalty.

The summons ending in 82L, the Respondent is requesting mitigation. The FDNY recommends mitigation for No. 2 and 3, but not No. 1 (VC 9). I concur and sustain with a standard peanlty of \$600 on No. 2 and mitigated penalties of \$300 and \$475 respectively on No. 2 and 3.

The summons ending in 80H, the Respondent is requesting mitigation. The FDNY recommends mitigation. I concur. I sustain and impose penalties of \$300 and \$475 respectively.

The summones ending in 05L, the Respondent is requesting mitigation. The FDNY recommended a standard penalty. I concur and impose a standard penalty. The standard penalty of \$950 is imposed.
