**Findings of Fact & Conclusions of Law**

The motion to dismiss is granted. In addition to the fact that there is no proof of service, the narrative box is completely blank, so there is no notice whatsoever describing the nature of the charges. Furthermore, the penalty box is also blank, so the

respondent cannot calculate the maximum penalty he faces if found in violation. The summons is dismissed.
