**Findings of Fact & Conclusions of Law**

Petitioner, the New York City Police Department, charges Respondent with a violation of Section 19-190(b) of the Administrative Code of the City of New York, for failure to yield to a pedestrian with a right of way and causing the pedestrian's injury.
