Findings of Facts & Conclusions of Law

A hearing was conducted by telephone on April 27, 2026. Nora Brown appeared for the respondent. The petitioner did not appear. The summonses each alleged a violation of NYC Admin. Code sec. 16-118(2)(b).

The respondent's representative provided a copy of a deed for the premises which showed that Wells Fargo Bank purchased the property on March 22, 2018. The respondent's representative stated that the property had gone into foreclosure and that, as a result, the respondent had no ownership of the premises when these summonses were issued. I credit the respondent's evidence and find that the summonses named the wrong respondent. These summonses are, therefore, dismissed.
