**Findings of Fact & Conclusions of Law**

Respondent, George Sher was issued the above summons for allegedly violating the New York City Administrative Code §19-190(b). Michael Nacmias, Esq. appeared remotely as Respondent's counsel. The Petitioner did not appear.

The details of the summons alleges filed to yield right of way, physical injury.

Respondent's counsel argued that since the affidavit of service was blank the summons failed to establish proper service. Additionally, he argued the details were insufficient to establish a proper charge of the cited section of law.

I credit the Respondent's argument and find the summons is defective for failing to establish service. Additionally, the details of the summons are insufficient and fail to set forth a prima facie case for the section of law charged.

Accordingly, the summons is dismissed.
